# ROADWAY AND INFRASTRUCTURE ORDINANCE FOR THE BOROUGH OF LANESBORO, SUSQUEHANNA COUNTY, PENNSYLVANIA

An Ordinance of the Borough of Lanesboro regulating public infrastructure and ingress / egress to the same from private lands.

The Borough Council of Lanesboro, Susquehanna County, Pennsylvania hereby ordains and enacts as follows:

## **1.100 Design Standards**

All applicable PennDOT design standards and guidelines shall be followed in the design of, construction of, deconstruction of, and reconstruction of public roadway and pedestrian facilities, and within right-of-way, ingress / egress to the same from private lands, with the following exceptions:

- a. Minimum grade on drainage pipes shall be 1%.
- b. Sumps shall not be used on inlets.
- c. Any inlets placed along a curblin e shall be a combination curblin e / roadway inlet.
- d. Minimum roadway widths on reconstructed roads shall be ten (10') feet wide travel lanes and five (5') feet wide shoulders.

## **1.200 Application of Ordinance**

No infrastructure element or part thereof shall be erected, deconstructed, constructed, reconstructed, or structurally altered unless in conformity with the regulations of this ordinance.

## **1.300 Interpretation and Validity**

1.401 Interpretation. In the interpretation and the application of the provisions of this Ordinance, they shall be held to the minimum requirements for the promotion of the health, safety, and general welfare of the traveling public. It is not intended to interfere or abrogate or annul other county, state, or national rules, regulations or ordinances, provided that where this Ordinance imposes greater restrictions upon the use of buildings or premises, or upon the height or bulk of a building, or requires larger open spaces the provisions of this Ordinance shall prevail.

1.402 Validity. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reasons held by a court of competent jurisdiction to be invalid, such a decision shall not affect the validity of the remaining portions of this Ordinance. The Council hereby declares that they would have passed this Ordinance and

each section or part thereof irrespective of the fact that any one or more sections or parts thereof be declared invalid.

1.403 Repealer. All existing Ordinances or parts of Ordinances in conflict and no further, are hereby repealed.

**1.400 Effective Date**

This Ordinance shall take effect immediately subsequent to the adoption thereof.
